Standard Arrival

In order to connect with our yachts you must arrive in Panama City, Republic of Panama, the night before the flight. We recommend that you stay in the [Trump](#), [Holiday Inn – Canal](#), [Sheraton](#) or [Bristol](#) Hotels.

If the itinerary starts in Panama City you'll be transferred directly to the Yachts in Flamenco Marina.

At the end of your trip you will be transported back to Panama City on board a charter flight.

Departure from Panama City

You should be able to make an afternoon flight from Panama City back to the USA, or elsewhere, provided your flight is 16:00pm or later.

We recommend you stay overnight at one of the hotels previously recommended.

Baggage Limitations

We have to observe the limitations and regulations listed below.

Please use discretion when packing for your trip and remember that we do have a laundry service available.

For flights each guest is allowed:

One suitcase not exceeding 30 lbs. (13.67 kg.)

One carry-on bag not exceeding 15lbs. (6.8 kg.)

We will send you 2 Lime I.D. tags for each person in your group. Please attach them to your baggage. They help us identify and expedite your rod cases and luggage through customs in Panama City.

Excess baggage pieces are standby and, therefore, subject to space and weight restrictions.

Travel Documents

Travel Insurance

Is recommended in the event of an unforeseen situation that would require you to cancel your trip.

If you are booking your trip through a travel agency, ask them about travel insurance. There are many companies that offer travel insurance, and most of them require the policy to be purchased at the time of making the initial trip deposit. Clients that have already paid their deposit or final payment can still purchase trip insurance.

United States Citizens

A valid passport is required to enter the Republic of Panama and the expiration date must be valid (6 months prior to arrival.)

Guests Visiting Panama from Other Countries

Must check with officials in their respective homelands as to what documents are required to enter the Republic of Panama.

If you arriving from a country other than the US, please check on a new Yellow Fever Vaccination requirement.

Government Contact Information

Be advised that required documentation is subject to revision; what was acceptable last month or last year may not be acceptable on the dates you are traveling.

Please check the Panamanian Embassy website www.embassyofpanama.org/cms/immigration3.php

It is your responsibility to check with your airline, your travel agency about any changes that may have been made by the Government of Panama that would require any additional information or documents.

Panama Customs Information (Important!)

Local Panamanian Customs Regulations are very similar to US Customs Regulations that make it illegal to import fresh produce, fruits and meats in the country.

All arriving foreign or local nationals must declare all monies, valuables or negotiable instruments (includes checks and travellers checks) that exceed the sum of \$10,000.00 on their person or luggage.

If you fail to omit or follow the law you will forfeit the monies, valuables or negotiable instruments that you failed to declare and worse yet you will face criminal prosecution, which if convicted is sanctioned with a:

NEW IN 2010 - MANDATORY MINIMUM TWO YEAR PRISON SENTENCE WITH A MAXIMUM SENTENCE OF UP TO FOUR YEARS IN PRISON.

This information is needed in order to satisfy domestic (Panamanian) airline requirements and to enable us to meet you upon your arrival at the international airport and arrange your transfers in Panama City. The other forms enable us to give you exactly what you want or require whilst you are with us. The release form is mandatory, one for each guest.

Private Jets

If you are arriving on a private jet into Panama City, we will need to have the following information:

point of origin of the flight,

tail number of the aircraft,

and estimated time of arrival in Panama City at Tocumen International Airport.

AND EACH OF THEIR EMPLOYEES, OFFICERS, DIRECTORS, AGENTS, AFFILIATES, OTHER ASSOCIATED PERSONNEL, AND PANAMA YACHT AND FISHING CHARTERS S.A., A CORPORATION OPERATING UNDER THE LAWS OF THE REPUBLIC OF PANAMA AND DULY REGISTERED AT THE MERCANTILE SECTION OF THE PUBLIC REGISTRY OF PANAMA, INCLUDING BUT NOT LIMITED TO ITS VESSELS, EQUIPMENT AND FACILITIES (WHETHER OWNED, OPERATED, LEASED OR CHARTERED, INCLUDING BUT NOT LIMITED TO ANY THIRD PARTY CHARTER BOAT, CHARTER BOAT CREW, CHARTER BOAT PASSENGERS OR FISHING GUIDES) AND HEREINAFTER COLLECTIVELY REFERRED TO AS "EXPEDITION OPERATOR", AND TO HOLD THESE ENTITIES HARMLESS FROM ANY AND ALL LIABILITIES ARISING AS A CONSEQUENCE OF THE FOLLOWING, OR ANY OTHER ACTS OR OMISSIONS ON THEIR PART, INCLUDING BUT NOT LIMITED TO NEGLIGENCE OF ANY TYPE:

1. I UNDERSTAND THAT THERE ARE RISKS INVOLVED WITH TRAVELLING AND ENGAGING IN WATERSPORTS ACTIVITIES INCLUDING BUT NOT LIMITED TO SPORTFISHING, OPEN WATER SNORKELING or DIVING, PADDLEBOARDING, SURFING, KAYAKING and JET SKIING (such activities individually an "EXPEDITION ACTIVITY" and collectively constituting an "OUTPOST EXPEDITION"), including but not limited to any personal injury, medical illness, loss or theft of personal items, and failure of equipment purchased in conjunction with or as a condition of engaging in such EXPEDITION ACTIVITY or joining such OUTPOST EXPEDITION, including any of the foregoing arising from acts of fellow participants and I HEREBY ASSUME SUCH RISKS.

2. I UNDERSTAND THAT THERE ARE RISKS INVOLVED WITH OFFSHORE FISHING, BOATING EXCURSIONS OF ANY TYPE AND WATERSPORTS, including but not limited to EXPEDITION ACTIVITY, any equipment failure, perils of the sea, harm caused by marine creatures (including bites), acts of fellow participants, boarding or disembarking boats, and activities on the docks and I HEREBY ASSUME SUCH RISKS.

3. I UNDERSTAND THAT I HAVE A DUTY TO EXERCISE REASONABLE CARE FOR MY OWN SAFETY AND I AGREE TO DO SO.

4. I fully understand that the involved boat or waterborne vehicle has limited medical facilities and that in the event of illness or injury appropriate medical care must be summoned by radio and treatment will be delayed until I can be transported to a proper medical facility. I agree in advance to these conditions.

5. EXPEDITION OPERATOR has made no representations to me implied or otherwise that it can or will perform safe rescues or render first aid. In the event I show signs of distress or call for aid I would like assistance and will not hold EXPEDITION OPERATOR responsible for their actions in attempting the performance of rescue or first aid.

6. I assert that I am physically fit to ride on a boat or other waterborne vehicle and I will not hold EXPEDITION OPERATOR responsible if I am injured as a result of ANY problems (medical, accidental or otherwise) which occur while fishing, riding on any boat or waterborne vessel, or participating in any fishing, boating, or watersports activity, or otherwise participating in any activities relating thereto.

7. IT IS MY INTENTION BY THIS INSTRUMENT TO GIVE UP MY RIGHT TO SUE ALL PERSONS OR ENTITIES REFERRED TO HEREIN, WHETHER SPECIFICALLY NAMED OR NOT, AND IT IS ALSO MY INTENTION TO EXEMPT AND RELEASE EXPEDITION OPERATOR AND TO HOLD THESE ENTITIES HARMLESS FROM ANY AND ALL LIABILITY FOR PERSONAL INJURY, PROPERTY DAMAGE, OR WRONGFUL DEATH CAUSED BY NEGLIGENCE OR GROSS NEGLIGENCE AND I ASSUME ALL RISK IN CONNECTION WITH FISHING AND BOATING ACTIVITIES INCLUDING BUT NOT LIMITED TO THE MAINTENANCE OF THE EQUIPMENT OR ORGANIZATION OF THIS ACTIVITY.
